Peru is a safe country and stable democracy, with a solid economy in South America. It is classified as upper middle income by the World Bank and is the 30th largest economy in the world by total GDP. Peru is one of the world's fastest-growing economies with a GDP growth rate of 6.3% over the last three years.

# PROCESS & TIMELINES

Peruvian citizenship naturalization process requires three visits to Lima, Peruvian capital, over a period of 30 months to complete. On every visit to Peru, our Senior consultants will assist the customer step-by-step through all the process.

The first visit to Lima is to receive the residency card (Carnet de Extranjeria) and requires only ten (10) working days.

Residents can spend as little or as much time in Peru during the 24-month residency period. In the course of this process, customers can use their Peruvian permanent residency card to travel Visa Free elsewhere throughout Latin-America.

Pre-Process      STEP 1: Client signs Marhaba Panama (MP) Retainer Agreement to execute immigration proceedings in Peru.  
STEP 2: Reference number obtained in Peruvian Consulate abroad to apply for a Work Visa  
STEP 3: Work Visa issued

Month 1            STEP 4: First Week-Long visit to Lima, Peru to obtain Permanent Residence with 24 months validity and for different Migration appointments (Criminal Records verification, fingerprinting, etc.)  
STEP 5: Expedition of Permanent Residency Certification (Carnét de Extranjeria)

Months 1 to 24    STEP 6: Work assignment at Home Country, with possibility to travel Visa Free to all Latin-American Countries

Month 25          STEP 7: Second visit to Lima to apply for naturalization and perform cultural exam. Approximately 10 working days required of stay.

Months 25 to 30    STEP 8: Naturalization process in progress.

Month 30            STEP 9: Third visit to Peru for naturalization certificate and citizenship ceremony. Passport issuance.

## Application Fees:

Further minor fees such as Official Government Citizenship Application Forms, Citizenship Certificates and expedite passport fees are additional and subject to change, therefore prior verification with a MP Senior Consultant is required.

## Timelines:

Please note that the Timelines are a guideline as processing times may vary depending on each individual case and the Government policy. This will be not the legal responsibility of MP. The grant of citizenship is at the sole discretion of the Government of Peru.
